- 2) Each organization can sell 1-2 main food items it corn and brats, hamburgers and hot dogs to allow several groups to benefit from the opportunity. We will try to avoid duplicates.
- 3) ECP reserves the right to assign vendor locations. Those registering for more than one day will have higher priority to space in the main event area.
- 4) Basic sanitary practices must be followed. ECP reserves the right to close down a vendor should sanitary or behavioral concerns arise.
- 6) Only vendors registered through ECP will be allowed in the festival area.
- 7) Two adults must be present in the booth at all times unless other arrangements are made with the Food Vendor chair.
- 8) Help with trash pick-up and end of day clean-up is required. Supply 1 person at least

The undersigned vendor agrees to the above restrictions and will abide by them.

Enclosed is a check for \$_____ to cover the costs of \$20/day or \$50 for all three days of vending. If this amount is more than 20% of the net proceeds (not including labor costs), a partial refund may be issued at your request providing documentation is provided no later than October 1, 2010.
